1.0 Preliminaries

1.0 Opening remarks from President

- EB meetings at EML and COLABIOCLI
 - Because the EML Congress has been rescheduled to April 10-14, 2022 it would not be practical to hold a full EB meeting at the COLABIOCLI Congress. A smaller group of EB members will attend the COLABIOCLI Congress and there will be no change to any EB sponsored presentations.
- Updates to EuroMedLab guidelines and a new contract for the 2023 Rome congress
 A new agreement with EFLM has been completed, and a new agreement is being
 negotiated with MZ. The goal is to achieve a fair distribution of income among all
 partners. The EB indicated support for both initiatives.
- Development of an IFCC Virtual Platform to provide a hybrid option for all future IFCC conferences/events
 - The IFCC should have a virtual option for all future conferences to meet the demand from the thousands of members who cannot attend conferences in person. IFCC should contract with a company for an IFCC branded option. KA is investigating options and estimates that the cost would be \$20,000 \$25,000 per year to include all IFCC events versus past costs of over 20,000-80,000 Euro per event (total annual

cost of over 100,000 in 2021). One potential provider is InEvent, based in the US and Europe (https://inevent.com/en/home.php). KA will forward information on potential providers to the EB. The EB indicated support for the initiative and a small committee will be set up to investigate options and report to the EB.

- IFCC Conferences (2023-2030) New Profit-Sharing Formula with the PCO KA will continue to work on securing a favourable new profit-sharing agreement with MZ for EML meetings.
- Call for Proposals WL 2024 2026 Brazil made a proposal for WL 2024 but then retracted it due to conflict with the COLABIOCLI conference in Columbia. ALMR says that the congress cannot be changed. COLABIOCLI is not ready to have a joint conference with WL at this time. Mexico may be interested in a bid for 2026. Other options might be in Asia again, in Dubai, in China, or in Eastern Europe in alternate year to EML. KA feels that this may not be the best time for proposals and a hold has been put the request for bids for now until the pandemic situation is more clear and national societies will be in a position to host future conferences.
- IFCC Regional and Corporate Member Townhalls: guidelines and schedule (outcome)
 The feedback on the townhalls was positive. The virtual platform worked well and the meetings were well organized. The guidelines for the townhalls will be updated for 2022. AMLR asked about the responses to the questions received, such as how committee members are chosen, the issue of countries in the same geographic region belonging to different Federations, and standardization of regulatory requirements for IVD products. A survey has been sent to participants and all issues/questions can be addressed after that. JP noted that the recent full week workshop with IFCC, JCTLM, BIPM that was very successful, was intended to address one of the townhall issues, that is to come up with position paper on
- IFCC Webinars
 The WorkCast virtual meeting platform is working very well and is very cost effective.
 The IFCC was paying \$3,000 per webinar for YS events as compared to a yearly cost of 10-12,000 pounds for about 25 Webinars from WorkCast this year. Each webinar has about 4,000 participants from over 100 countries. KA, Silvia and Smeralda developed guidelines for webinars that will standardize presentations, regardless of the presenter or coordinator. As of Jan 2022, the plan is for 2 webinars per month, 2 weeks apart. The TF has approved the guidelines.
- IFCC Global Lab Week
 The committee is meeting regularly and the regional representatives have joined the committee. A call will go out for corporate members, YSs and champions. Videos and slide presentations have been developed.
- Proposed membership for the New Taskforces
 TF-GRID chair is Prof Zirk from Germany and the TF has had one meeting so far.
 TF-OSLM, members have been selected but the chair has not been identified. KA is interviewing a prospective candidate. IFCC Executive Board Strategic Meeting with Division Chairs and Division Executives
 The uncertain COVID situation and increased travel restrictions make planning this meeting difficult. Thus it will be delayed until March. PB will advise the hotel.

2022 Budget

The rescheduling of the EML Congress did result in some costs that AHA is addressing, including reimbursement for travel cancellations that were not refundable. It was noted that delegates should avoid purchasing tickets that cannot be rescheduled, or cancelled with a credit, or refunded with a small penalty. The purchase of fully refundable tickets is not recommended, as these can be quite expensive.

Estimated income for 2021 is 1million 40 thousand SF, which is reduced due to cancelled congresses. In the proposed budget for 2022, AHA is expecting 1million 40 thousand SF income. If all goes as planned we may have more than 2 million SF income, but only 700 SF if meetings are not successful. There may be a need to be conservative in expenses if our income is significantly reduced. Functional group budgets will be the same as last year for most, with some increases in ETD. In general the budget will support 2 physical meetings for each group, ideally at EuroMedLab Munich and the General Conference. At present there is an estimated deficit of over 800,000 SF, but there are sufficient funds in savings from 2020 and 2021 to offset this. AHA, KA and DK will meet to finalize the proposed budget prior to review and approval by the EB in January.
