1.0 **Preliminaries**

1.0 Opening remarks from President

WorldLab 2026 bidding process

KA had meetings with the APFCB, ACBI and MCAB board representatives. It was agreed by all parties that ACBI will request that their application be reconsidered, and the MACB will not bid while the ACBI is being considered. KA recommends that the C-CC evaluate the India bid and if acceptable proceed to EB for approval, and if not, a new request for bids will be issued. The EB voted to go ahead with this recommendation.

Updates on Dubai 2024 WorldLab COC and Scientific Congress Committee (June 13-14 meeting of the COC)

Stefano from MZ joined the discussion by Zoom. The COC meeting was held in Dubai in June, and included a meeting with goverment officials and the Dubai Genetic Association. AHA represented the Arab Federation and Saudi Clinical Chemistry Society representatives were there, as well as MZ Events. It is hoped that the Dubais Genetic Society will facilitate interactions and support from the government (including the provision of visas for delegates), advertise the congress and encourage delegate attendance, provide some scholarships for young scientists, contribute to the scientific program, and support any local activities required in Dubai. The EB discussed options and felt that it may be best if the 2 events are held in parallel with separate finances and each party (IFCC and the Genetics Society) manage their own sponsorship and cover their own costs. There would be a single registration at the same fee but delegates can attend any events. The Genetic Society would receive the income from their delegate registration, minus a fee for managing the registration process.

Plans for acceditation of future WorldLab Congresses: IFCC CE Program or EFLM CPECS?

IFCC and EFLM are working on an MoU to work together on providing CE for IFCC events. It was suggested that this activity could be part of a WG under EMD, with a chair who understands CE accreditation. The functional group could be a committee or a task-force but a WG would be faster and easier to set up and start working as soon as possible. The WG could be converted to a committee or a TF at a later date, if desired. This group could also work with the EFLM CPECS committee. The EB agreed to form a functional group focused on CE. DK and KA will move forward.

IFCC Young Scientist Forum at Dubai 2024 Congress

The EB previously approved 50 scholarships for the Dubai YS Forum. In addition discussion is underway for Roche to provide some funding; the Arab and Saudi Societies will try to provide some funding; and the Dubai Genetics Society said they will provide some funding. It was previously agreed that YS Forum will be held at all future WL and EML congresses, and secondly that a minimum of 50 scholarships will be provided by IFCC. The EB formally approved.

IFCC-ICHCLR Relationship/Formation of new Working Groups

There have been some issues between ICHCLR and the IFCC SD group over the development of ICHCLR Working Groups. Sverre will step down as the IFCC Representative on the ICHCLR Council and Chair at the end of this year. Ian Young is the Chair of ICHCLR Steering Committee. The IFCC has indicated that we do not support independent ICHCLR WGs but do support joint WGs between ICHCLR and SD, under the SD structure.

Changes to IFCC Election and Membership By-Laws

KA will write a letter to all Council members to advise them of the proposed changes to the By-Laws (expand membership to other specialties in Lab Medicine and not just clinical chemistry for both Full Members and Affiliates, plus no person can hold office for more that 6 years total in any one EB position, plus changes to the election cycle so that voting for officers occurs at the same time, and a person cannot be nominated for more than one position in any election cycle). The changes were dicussed at previous EB meeting and no objections were raised. EB members should review the changes and suggest any edits.

Proposal for participation at the Chinese Society of Laboratory Medicine (CSLM) Conference

Initially a joint meeting with the Chinese Society of Laboratory Medicine was proposed for 2023. China could not get approval for the meeting in 2023 but want to invite an IFCC

delegation to attend their annual conference and present a symposia in September 2024. The APFCB will be there also. IFCC will cover their own flights and China will provide accomodations and meals. An EB meeting may also be arranged in conjunction with this meeting. The EB voted to approve.

Global MEDLAB Week 2024 - Future plans

The Global MEDLAB Week has grown over the last 2 years, and while it has been very active in some countries, there is more that could be done. It was questioned if this initiatve should this stay with PR Committee or become a program on its own under a separate group where it can be more active. The Chair of the PR Committee, Rajiv, will join EB as the Representative for African Federation so a new Chair is required EH feels there should be more Corporate members who know about marketing. Two to four other members, some with experience in marketing and promotion, could also be appointed, or be added as consultants. The initiatve needs a new name, such as the Committee on Public Relations and Global Med Lab Program (Promotion, etc.). Also, need a new tag line for 2024, such as "Labs save lives" (borrowed from CSMLS in Canada).

Proposal on Medical Decision Support by Hernan Fares Taie

A proposal has been received to form an SD Working Group to work on a Post Analytical Medical Decision Support application to support patient care, based on the Socratic system with Al. Hernan has offered to make a presentation to explain what he would like to do. The EB members expressed some concern about the mangnatude of this project and the resources required, plus who would use the applicartion. A meeting with Hernan will be organized.

MOU with EQALM

The signed MoU from KA has been sent to EQALM and there has not been a response. A minor change was made, and KA will sign that version to be sent to EQALM.

MOU with Balkan Clinical Laboratory Federation The MoU has been finalized and signed.

MOU with FIFBCML-Francophone Federation

KA has followed up on the MoU but has not received a reply yet. We believe that FIFBCML made a change to their bylaws and are waiting on final approval. This should be completed by fall.

WASPaLM collaboration (WASPaLM Symposium at WorldLab 2024 in Dubai and IFCC Symposium in Sao Paulo)

A final speaker for the WASPaLM Congress in Sao Paulo is being arranged. KA asked SPC to send a letter of invitation to WASPaLM to present at WL Dubai and a proposal has been sent.

IFCC Practice Guidelines in Laboratory Medicine – Development of a Roadmap/Steering Committee

A meeting of the Avisory Group was held in June and KA is revising the Terms of Reference based on the feedback. The term "Guidelines" was thought to be too formal and restrictive for all documents generated. Thus the focus will be on "Best Practice Recommendations" which will be practical, shorter and simpler than guidelines, and not require the intensive effort and collaboration to produce. For example, clincal laboratory consensuc statements or position papers, based on evidence. Some Clinical Guidelines, following the usual stringent procedures and a grading system (ADLM Academy or EFLM) will also be produced. To noted that the EFLM is also working on similar docments and the two groups should work together. KA will finalize the ToR as a Road Map for for the development of recommendations and guidelines and will send them to the Adisory Group

and to the EB. The plan is to launch the program in September and invite proposals. A Steering Committee will be required to manage the project and a Task Force will be created initially, transforming to a Committe under the EMD after 2-3 years. The EB approved.

15.2 2023 Financial update

Credit Suisse Update

There was a unrealized loss of over 500,000 SF in the market value of IFCC investments last year due to world market fluctuations and difficulties with Credit Swis, but the investments are expected to rebound going forward.

Financial Statement

PB and AHA have verified the final financial statement for 2022 prepared by KPMG, with over 7 million SF in accounts and investments as of the end of December. The EB approved the release of the statement to the Swiss Lawyers for tax purposes. Rome Congress Audit

KPMG has not provided a quote for an audit of the finances from the Rome Congress. AHA will follow up with KPMG again and if they cannot perform the audit, or do not respond, then another international company will be approached to peroform the audit. The EB approved the plan for an audit. KA reported that Rome congress was the most successful to date.

a) New Task Forces:

13.1.17 Task Force on Global Newborn Screening (TF-NBS)

Task Force members have visited several countries including South Africa, Romania and the Dominican Republic to meet with government representativess and local society members. Some progress is being made but no screening programs have been set up as yet. The Task Force has submitted a new proposal for a two day conference in Nigeria at a cost of about \$21,000 for Jim B and other speakers to present. It was suggested that the Task Force have a meeting with representatives from the EB to brainstorm on ideas that will allow them to meet the initial objectives for the Taks Force. TD feels that the TF is passionate about what they do but don't know how to take the next step of setting something up in a specific country. TD feels they need someone on the TF that has the skills to do this. A meeting will be arranged and a decision on the future to be made in Prague.

13.1.18 Task Force on Global Lab Quality (TF-GLQ)

The TF is active. The focus has been to supply free EQA via OWA to 50 labs initially and now to 100 labs in 10 developing countries. Most countries are doing quite well in the surveys. The next step is to provide education and training in QA and IQC for developing countries and a training session is planned in Columbia. Quing will reach out to AMLR. It was suggested that these training sessions should be developed into webinars, using

WordCast, that could be educational tools in the e-Academy. A meeting should be arragned with the TF and Smeralda, KA and AHA to explain what is needs to be done. This TF is coming up for renewal in December and membership will need to be reviewed.

13.1.19 Task Force on Outcome Studies in Lab Med (TF-OSLM)

The TF is very active, meeting every 2nd month with email activities in between. The grants awarded last year have all been finalized. The call for new grant applications has been sent out. The TF is working on the literature reference database with Digiwedo. The TF is working with ADLM on identifying new literature references supporting the value of laboratory medicine. One goal is to identify key references and then advertise them via the IFCC website, eNews, eJournal, ADLM resources, and social media, and possibly work with CPD to promote awareness of the program. The TF has published an opinion paper on the value of laboratory medicine in Clinical Chemistry.

13.1.20 Task Force Global Ref Intervals database (TF-GRID)

The TF is very active, meeting monthly. They met in Rome for almost all day and then again less than a month later. The TF is working with Digiwido on the database for reference intervals that will be in place at the end of the year. They will also develop a tool to establish reference intervals on line. Mary Catherine is the YS on this TF. This group will accomplish their goals.

13.1.21 Task Force on Global eLearning/eAcademy (TF-GEL)

Webinars are planned until February, 2024. The goal is to go beyond webinars and develop courses and workshops for training. All of the committees and task forces should submit course material, and a notice will go out asking for this. AMLR noted that the TF-GLQ could do this right away, as they have prepared one in Spanish and English. Another possible webinar is on the Clinical Lab and the Environment. AMLR is working with Nader to translate the Adaptive Learning Program into Spanish. It was suggested that young scientists may be able to help verify the translation that was initially done via AI. The name of the program will need to be changed from AACC Learning Lab to ADLM Learning Lab. KA feels that the IFCC should have its own learning platform.

13.1.22 Task Force on Environmental Impact of Laboratory Medicine (TF-EILM)

The task force met this week and is meeting monthly. It was noted that Tony will be coming onto the EB in January and cannot stay as the chair of the TF, but he could stay as the EB Liaison to TF. KA will ask Tony to recommend someone to become the chair for the end of the year.

13.0 Task Forces

13.1.1 Task Force on Ethics (TF-E)

One new member M. Zaninotto (IT) was approved, time in office 2023-2025. Nelda recommended Joe Wiencek as the new chair when her term is over at the end of this year and Joe is willing to accept the position. The EB approved this. Joe will be asked to meet with the TF and propose an action plan and deliverables for next term.

13.1.6 Task Force Young Scientists (TF-YS)

Positions have been renewed and vacant positions have been filled. The task force is very active. They are organizing a YS Forum for Dubai. They conducted a survey about knowledge of EQA and will prepare a report. There was a request to have more corresponding members but the rules permit only one corresponding scientist per National Member or Affiliate. It may be that another category coud be defined, or all interested young scientists could be put on a mailing list for minutes and announcements. KA will talk to Santiago to get his ideas.

13.1.12 Task Force History (TF-H)

Bernard had planed to finish the IFCC History book for the Rome congress but this has not been possible. A student in Milan in going thought the archives in the basement of the office and digitizing the old records.

13.1.15 Task Force Corporate Members (TF-CM)

Tricia will recommend a member of the TF-CM to sit on the 2024 EB. JP is stepping down from the TF-CM and will nominate someone from Roche to take over from him . JP wrote an artice for the e-News and there will be three more from other Corporate members, focusing on what IFCC does in the laboratory medicine space. There was very good feedback from Corporate Members on the Rome meeting and the only concern expressed was the challenge in preparing for yearly IFCC meetings. There is a lot of excitement in the Dubai meeting but we should not expect the same type of attendance as seen in Rome. JP suggested that a meeting in China would be very attractive to the Corporate members. The challenges in holding a meeting in China are the financial arrangements, the difficulty in obtaining a government visa for meeting, and the language.

13.1.16 Task Force on COVID 19

This task force has been closed and letters of thank-you sent to the members. AH suggested that the IFCC should have a task force on infectious diseases. TO noted that the EFLM has an emergency preparedness committee and perhaps the IFCC should have something similar.

All TFs need to have a Young Scientist in place for the next term.

The 2nd Latin American Conference of Young Laboratory Professionals was held in Florianopolis, Brazil, June 18, 2023. The first COLABIOCLI Regional Conference will be held in Guatemala City, November 21-22, 2023. KA will attend and make a presentation. The COLABIOCLI Congress 2024 will be held in Cartagena de Indias, Columbial, October 2-6, 2024. IFCC and AACC potential collaborations re global initiatives

A Leadership meeting with AACC was held Monday, July 24th 2-3pm at the AACC Congress in Anaheim.

ADLM Update

The most significant issue for AACC is the name change to ADLM (Association for Diagnostics & Laboratory Medicine) which became effective at this congress. AACC/ADLM is also celebrating the organization's 75 year anniversary. The next major event is the Middle East Conference in October and thereafter the POCT and Automation conferences.

WL Congress with ADLM in 2028

The ADLM is committed until 2030 for conference locations, and there is not a lot of flexibility. It would make it difficult to accommodate a conference with the IFCC. Alternatively, another event before or after would be possible. Perhaps a smaller meeting focused on a specialized area of laboratory medicine. It was noted that a combined IFCC/ADLM meeting would be easier for corporate sponsors in that it would be one less meeting for corporate sponsors to attend.

Newborn Screening in Developing Countries

It was agreed that there are opportunities for the 2 groups to work together to facilitate Newborn Screening in developing countries. It was noted that Van is on both the IFCC and ADLM TFs. Currently there is no activity by the ADLM group but they are willing to work with the IFCC. The CDC is also interested in this area and might be interested in working with IFCC and ADLM on this project. Working together and reinforcing each others efforts may allow all to be more successful in setting up and maintaining programs.

Global Quality in Developing Countries

Currently there are 100 labs in 10 developing countries receiving QA materials from OWA. The TF is also organizing workshops on quality. This is another opportunity to work together and complement each others efforts for sustainability. There could be on-line certificate programs in cooperation with the IFCC program. There could have IFCC representatives at ADLM planning meetings to help with cooperation and sharing of information.

OSLM and ADLM Visibility of Lab Medicine

Evidence is important. It is somewhat difficult to find in terms of solid outcome based data. DK and Zhen are on ADLM VLM. IFCC grants have gone out for last year and grants have been adverstised for this year.

Global Med Lab Week Celebration

The Global Med Lab Week celebration is another area where IFCC and ADLM could work together. Another organization has been the primary lead on this in the US but it may still be possble to work together.
